## Agreement for Future Occupancy

3. Upon notification that the bungalow/town house / apartment of your choice is available, you will have three days to complete the reservation agreement, pay the required security deposit and sign the lease. Move-in/Rent responsibility is within thirty days.
4. There are no guarantees, implied or promised. If you decide not to move to Brickstone by St. John's when notified, this AFO is terminated. You may reapply.

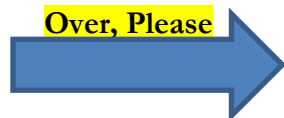
